**Appointments from the March 5 Board meeting:** Five Board members accumulated 4 or more absences in the last year. This meant that they no longer meet Board Member requirements, and their seats were vacant. As required by the bylaws (Article V, Section 7 and Section 6), those seats were filled by appointment at the last Board meeting on March 5. Five people applied for the vacant seats at the March 5 meeting. There was one application for each vacant seat. A representative of the Department of Neighborhood Empowerment expressed the opinion that applicants should have applied in advance and should have been named on the agenda, and that filling the vacancies should be deferred to the next meeting. The Chair and one other Board member noted that the bylaws only require that "the matter" (which the council interprets as meaning "the vacancy") should be placed on the next agenda. The Board seated five people to the vacant seats, despite the objection. However, the Board did not count votes from any of those five newly seated Board Members and Alternates, pending a possible review of the issue by the City Attorney. If the Council has not received a written objection to its action from the City by the time of this meeting, it will continue with the newlyappointed people acting in their full capacity. It the Council has received a written objection to its appointment actions of March 5 from the City Attorney, it will consider an action to re-affirm its five appointments at this meeting. (10m)

- 7:32 11. Appointment of special representatives and alternates, including DWP, Homeless, Public Works, Animal Services, Aging and other representatives to citywide efforts. These representatives do not need to be members of the Board. The positions do require occasional meetings downtown. At least one of the representatives of a particular type should read English because many information materials are not translated into Spanish. (3m)
- 7:35 12. Consideration and possible action on a proposed condominium development project on a 3.13-acre site at 15508 West Plummer Street and 9433 North Sepulveda Boulevard. The project seeks a general plan amendment, zone changes, a building line removal, a site plan review, and vesting of tentative tract map 73939. The planning case numbers are CPC-2015-4184-GPA-ZC-BL-SPR, VTT-73937, and ENV-2015-4183-MND. This is a modification of a plan that the Neighborhood Council supported on August 15, 2016. On December 5, 2016, the Neighborhood Council ALSO supported the alternative of a small lot subdivision on the Plummer Street parcel and an apartment building on the Sepulveda Boulvard parcel. The current proposal is a redesign of the original condominium project at the request of Council District 7. The new design increases setbacks from adjacent homes, removes some rooftop patios, changes sightlines, provides additional vegetation, and enhances the exterior appearance of the buildings. (20m)
- 7:55 13. Consideration and possible action on the recommendation of the Land Use Committee to support a school project at the Valor Academy High School campus at 9334, 9342, 9346, 9356, and 9400 N. Lemona Avenue, which is currently under construction following the approval of a conditional use permit (CUP) granted by the City Planning Commission on September 22, 2016 in Case No. CPC 2016-1387-CU-SPR. The public charter high school was approved on the 2.3-acre RA-1 zoned site for a maximum enrollment of 500 students, with 35,685 square feet of total development including demolition of the existing single-family dwellings and duplex, construction of a single-story 9,280 square-foot multipurpose/administrative building along the northern portion of the property and a two-story, 26,405 square-foot classroom building, an outdoor play area, and a 64-space parking lot.
